HOLD HARMLESS WAIVER AGREEMENT

In return for use of premises, instruction in firearms, archery and hunting, and/or for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledge, the Undersigned agrees to the following:

To indemnify, hold harmless and defend Highland Rod and Gun Club, and any of its employees, directors, officers or agents from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with the use of the property and facilities, use and/or discharge of firearms, archery and hunting; the Undersigned's participation in using and/or discharging firearms, archery and hunting, using buildings, using the land and the premises used (the "Premises"); the Undersigned's presence on or use of Premises; and any and all acts or omissions of the Undersigned. Should any such claim, demand or lawsuit arise or be asserted in any way related thereto, whether arising under the laws of the United States, or any State, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend Highland Rod and Gun Club, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against Highland Rod and Gun Club, whether individually, jointly, or in concert with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

The Undersigned waives any and all rights and claims for damages, losses, demands and any other actions, which exist or which may arise against Highland Rod and Gun Club, (including, but not limited to any and all injuries, damages or illnesses suffered by the Undersigned or the Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: use and/or discharging firearms, archery and hunting, the Premises, including any latent defect in the remises; the Undersigned's presence on or use of Premises; the Undersigned's property (whether or not entrusted to Highland Rod and Gun Club); Highland Rod and Gun Club shall not be liable for, and the Undersigned, hereby expressly releases Highland Rod and Gun Club from any and all such claims.

This waiver is both personal and on behalf of any minor for whom it is executed. This instrument binds the Undersigned and his/her executors, administrators, assignees or heirs and any minor for whom it is signed.

I acknowledge that I am aware of the potential dangerous nature of the activities and voluntarily and knowingly assume the risk for any injuries that may be sustained during the pursuit of Firearm, Archery and Hunting activities at Highland Rod and Gun Club. The Undersigned hereby expressly assumes the risk of entering the Premises and taking part in activities on the Premises which include, but are not limited to the use and/or discharge of firearms and the firing of live ammunition; or observing individuals discharging firearms; and/or the use of the club or camping facilities; archery and hunting.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all Highland Rod and Gun Club range, archery and hunting rules, procedures, safety rules, and any and all Range Officer instructions, whether communicated in writing, posted on the premises and/or communicated verbally.
