- If granted permission, any dues collected after February will have a late fee of \$50 per month.
- Two months of late charges are allowed, at month three the member will need to reapply.

LETTER TO MEMBERS 2026

Hello Highland members,

There are several rule reminders we need to share with you as we look forward to the new year.

Clubhouse – Smoking, e-cigs and vaping is prohibited in the clubhouse. Any member, or their guests, caught smoking in the clubhouse will be assessed a \$200 cleaning fee. Members who leave a mess in the clubhouse (trash, dishes, empty cans/bottles, etc.) will be assessed a \$200 cleaning fee. Repeat offenders will be subject to a disciplinary hearing.

Sponsorship – Members in good standing are allowed to sponsor two new members per year. Sponsors are required to attend prospective member interviews with the Board of Governors. Failure to attend will delay the prospective member's application. Sponsors are responsible for new member's behavior for the first 12 months and will be summoned along with the new member for any disciplinary hearings related to the new member's actions. Failure to attend will result in the suspension of your membership.

New members – New members are not permitted to have guests on the rifle/pistol range & trap for the first 6 months of their membership. New members are on probation for the first year of their membership – renewal for a second year of membership is not a guarantee.

Guest policies – Members are **solely responsible** for their guests. Guests who violate club rules will be forbidden from club property, and the member will be summoned to a disciplinary hearing.

Rifle/pistol range – If a member brings guest(s) to the range **only one person** is allowed to be handling firearms and/or shooting. No more than one guest is permitted in front of the red line at any time. All other guests must be sitting behind the red line. If a guest is shooting the member must be giving their undivided attention to the guest: within arms-length, watching them shoot, monitoring for safety, etc. If a member plans to bring 5 or more guests to the rifle/pistol range they must contact the BoG so a trained RSO (range safety officer) can be present.

Trap – Sunday & Wednesday trap is not open to the public. If a member brings a guest to shoot trap and the guest is not experienced handling a shotgun, the member must stand next to the guest as they shoot. The member is there to ensure safe use of the shotgun: misfires, prevent the guest from mishandling the shotgun, swinging the gun around, etc.

Key fob – Each member is issued a single key fob for their own use. Members are not allowed to lend their key fob to another member, a guest or family member. Failure to comply with this rule will result in disciplinary actions. If a member loses their key fob it must be reported (email contactus@highlandrodandgun.com) so it can be disabled. A replacement key fob will be issued at the cost of \$20.

We appreciate your adherence to these rules and the safe use of the club.
